These 5,500 ordinary shares were awarded to Mr. Carestio on May 30, 2017. These vested shares were valued at the NYSE closing market price on June 1, 2021.
- 13,900 of these ordinary shares are restricted. The restrictions on these ordinary shares lapse as follows: 2,712 on May 31, 2022; 1,748 on October 3, 2022; 5,008 on May 31, 2023; 3,324 on June 1, 2023 and 1,108 on June 3, 2024.
